

# Privacy Statement

Please read the present Privacy Statement ("Privacy Statement") carefully. In this Privacy Statement the way in which Newco Europe B.V. ("Newco") collects and uses personal data is set forth. All information that you provide to us or that Newco processes will be handled strictly confidentially by Newco and the processing of that data will comply with applicable laws and regulations. Please refer to this website regularly, as the content of this website and the Privacy Statement are updated regularly.

## Website

This website, [www.newco-europe.co.uk](http://www.newco-europe.co.uk) (hereafter: "Website"), is owned by Newco, located at Adriaan Mulderweg 9-11 (5657 EM and with chamber of commerce number: 20111712), Eindhoven in the Netherlands. If you wish to enter into any purchase with Newco, you need to register this. This privacy Statement applies to all data provided to Newco in the context of entering into purchases with Newco and also applies to the use of this Website. Newco respects the privacy of every person visiting this Website (hereafter: "User") and ensures that personal data is treated confidentially.

### Which information does Newco collect?

Access to this Website does not require the User to provide any personal data. However, for certain parts of the Website, such as the order section, the User does have to provide personal data. Newco uses the personal data as follows:

Any User or customer who wishes to place an order by Newco needs to register itself. On this Website this can be done by completing this registration form. The data Newco needs from a User or customer in order to be able to carry out an order are: contact information, the company name, the Chamber of Commerce number, the VAT-number and the invoice- / shipping address. This data (hereinafter: "**customer-or personal data**") is stored by us in a secure customer database and linked to a customer number.

### On which legal grounds and for which purposes are your customer-or personal data collected?

Newco only processes your customer- or personal data on the basis of the following legal grounds and purposes:

#### Legal grounds

- the execution of contracts, so that orders can be processed by Newco and we can inform you about this;
- compliance with legal obligations; and
- legitimate interest.

#### Purposes

- so that you can order products on our website. Newco stores customer- or personal data, whether or not provided to her through completion of the above mentioned registration form, and data relating to an order and the use of this Website in an account. By collecting this data, Newco can make the online order process quicker for the User, data already collected remains available in the account, so no new forms need to be completed with each new order;
- sending electronic newsletters. By registering as a customer, whether or not via the Website, the User gives permission to Newco to use its e-mail address so that it can be informed by means of a newsletter about the development of this Website about special offers and promotions. Each User can unsubscribe from this newsletter via their personal account or by clicking on the unsubscribe link in the e-mail with the newsletter or by sending an email to [masterdata@newco-europe.com](mailto:masterdata@newco-europe.com);
- to handle your questions and complaints per e-mail, registered post or per telephone; and
- in addition to customer- or personal data, Newco also collects and processes information about the usage of, and feedback on this Website, this ensures that Newco can further develop and improve this Website. However, the results of marketing and statistical research cannot be traced back to individual customers.

Newco will not process customer- or personal data for other purposes or on other legal grounds, unless this is permitted by law or if you have given your permission for this.

## Confidential treatment of customer- or personal data

The employees of Newco and the third parties engaged by Newco are required to respect the confidentiality of customer- and personal data. Customer- and personal data will not be sold to third parties and will only be made available to employees of Newco and/or third parties involved in fulfilling an order. In addition, Newco will not provide the customer- or personal information you provide to her to third parties, unless you have given permission for this, or if this is necessary for the execution of the agreement or if this is permitted by law.

## Data protection and storage of customer- or personal data

Newco has implemented the necessary security measures to prevent the loss, unauthorized use or modification of information that we will receive on our Website. If we transfer customer- or personal data to third parties with whom we are contractually bound, these third parties must ensure a secure connection on which customer- or personal data can be exchanged.

Newco uses technology to protect the customer- or personal data of each customer or User, such as a secured server and a SSL-connection during the ordering process and the completion of contact forms. Through hyperlinks available on this Website, third party websites can be accessed. The use of such websites is governed by the privacy policy of those websites and not by this Privacy Statement.

Newco will store your customer- or personal data as long as you are a customer of Newco or as long as the law prescribes it. Newco will always comply with applicable laws and regulations for the security and storage of your customer- or personal data. Your customer- or personal data will also be deleted upon your request.

## Right of access, deletion or correction

You can submit a request to Newco to inspect, correct or delete your customer- or personal data. In addition, you can submit a request to transfer this information to another party, or to limit the processing of your customer- or personal data (temporarily) and / or to object the processing of your customer- or personal data.
